Georgia Student Finance Authority (GSFA) offers the Student Access Loan Program for eligible students attending Georgia College. The SAL is a 1% fixed rate loan, designed to assist undergraduate students who have a gap in meeting their educational costs. Georgia College Financial Aid Office attempts to notify all possibly eligible students when applications are accepted by GSFA.
