DMA Enhancement Project

In February 2024, The University System of Georgia Office announced that it will begin work on a <u>Degrees and Majors Authorized (DMA)</u> enhancement project during spring. The DMA project includes improvements to the underlying DMA database, corrections to the existing data in the database, enhancements to the public interface used by campuses, and the creation of a public academic program search tool for Georgia Degrees Pay. The USG institutions were divided into clusters for a phased approach. Groups were established based on number of programs, reaccreditation dates, institutional spring breaks, and feedback from Provosts. Georgia College was placed on the June 2024 group. Academic Affairs will be working with the USG on the completion of the project.

Summer Orientations

In June, the Office of New Student Programs will host four of six Summer Orientation events for incoming freshmen. June Orientation dates are June 4, 6, 11, and 13. Currently, there are 1,023 students registered for June Orientations. Counting guests, we are expecting to welcome over 2,500 visitors to campus in the first two weeks of June. During orientation, students and their guests will have the opportunity to hear from a variety of departments, meet with staff from their respective majors, explore campus, and learn about various organizations and clubs at Bobcat Marketplace. Students will also spend time in breakout groups with their Orientation Leaders, where they will begin to build relationships with their peers and gain a sense of belonging as a part of the Bobcat family. July Orientations will take place July 23 and 25. Transfer students will attend orientation on July 24.

High Impact Practices (HIPs) Summer Institute

The 5th Annual High Impact Practices (HIPs) Summer Institute: Incorporating Transformative Experiences in the Classroom will begin June 10. This Institute is a unique opportunity for instructors to enhance their teaching methods and student engagement by incorporating a transformative experience/high-impact practice into a course or developing a course around an experience: Career Planning, Community-based Engaged Learning (CbEL), First-Year Experiences (TREK), International Education, Leadership, or Mentored Undergraduate Research & Creative Endeavors (MURACE).

A number of mentors are involved in shaping the summer experience for instructors. These include *Career Planning*, Ms. Lauren Easom; *Community-based Engaged Learning*, Dr. Liz Speelman; *First Year Experience (TREK)*, Dr. Kasey Karen; *International Education*, Dr. James Callaghan; *Leadership*, Dr. Harold Mock; and *Mentored Undergraduate Research and Creative Endeavors*, Dr. TM Chiang.
